CONTRACT AGREEMENT

THIS AGREEMENT made this **15th** day of **November 2023** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines (hereinafter called the " Entity") of the one part and **EMMA BUENVIAJE BERCASIO** proprietress of **SKYPRO LIGHTS & SOUND RENTAL** (hereinafter called the "Supplier") of the other part:






