CONTRACT AGREEMENT

Contract No. 2023- 2548 SVP

THIS AGREEMENT made this **1st** day of **December**, 2023 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **JUDITH A. TUMALAD** proprietor of **JAD EVENTS & CATERING SERVICES** (hereinafter called the "Supplier") of the other part:

WITNESS

WHEREAS the Entity invited Bids for certain goods and ancillary services, **RENTAL OF VARIOUS FOOD CARTS, PRINCE & PRINCESS COSTUME, MASCOT FOR THE CHRISTMAS CELEBRATION @ SORSOGON CITY** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Five Hundred Sixty-Eight Thousand Five Hundred Pesos (₱ 568,500.00) Only** (hereinafter called "the Contract Price").

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Five Hundred Sixty-Eight Thousand Five Hundred Pesos (₱ 568,500.00) Only** or such other sums as may be ascertained, **JAD EVENTS & CATERING SERVICES** agrees to the **RENTAL OF VARIOUS FOOD CARTS, PRINCE & PRINCESS COSTUME, MASCOT FOR THE CHRISTMAS CELEBRATION @ SORSOGON CITY** in accordance with his/her/its Bid.






