The City Government of Sorsogon, through the CEO-Continuing Appropriation 2023 intends to apply the sum of Eight Million One Hundred Ninety-Three Thousand Two Hundred Seven & 79/100 Pesos (₱ 8,193,207.79 ) Only being the total Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF BIRTHING HOME (INFIRMARY) @ Brgy. San Juan (RORO) East District under Project Reference No. CW 2024-02-001 . Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *City Government of Sorsogon* now invites bids for the above Procurement Project. Completion of the Works is required *with in* <u>315 calendar days</u>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Bids and Awards Committee of the City Government of Sorsogon* and inspect the Bidding Documents at the address given below from 9:00A.M to 3:00 PM Only.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *March* 1, 2024 from given address and website/s sorsogoncity.gov.ph and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Ten Thousand* (P 10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees.
- 6. The City Government of Sorsogon will hold a Pre-Bid Conference<sup>1</sup> on March 11, 2024 @ 9:00am at BAC Office, City Hall, Cabid-an, East District, Sorsogon City which shall be open to prospective bidders however SHALL observed compliance with the requirements stipulated in the ITB.
- 7. Bids must be duly received by the BAC Secretariat on *March 25*, 2024 at 8:00 A.M through the authorized representative of the bidder . Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on *March 25*, 2024 at 9:00 A.M. at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *City Government of Sorsogon* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and
