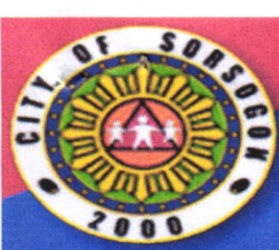

Contract Agreement
No. B- 2024-060-GS

THIS AGREEMENT made this 22nd day of February, 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and MS. JOANNA MABELLE M. BELTRAN Proprietor of JMBEL Enterprises (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY AND DELIVERY OF ADVICACY UMBRELLA WITH PRINT** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum to **Eight Million Ninety Five Thousand Five Hundred Pesos (₱ 8,095,500.00) Only** (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Eight Million Ninety Five Thousand Five Hundred Pesos (₱ 8,095,500.00) Only** or such other sums as may be ascertained, **JMBel Enterprises** agrees to **SUPPLY AND DELIVERY OF ADVICACY UMBRELLA WITH PRINT** in accordance with his/her/its Bid.


4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





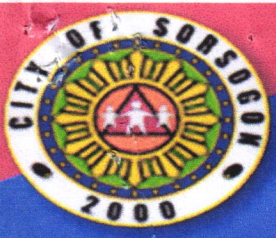
