



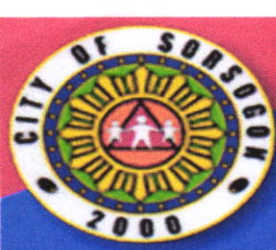

**Contract Agreement**

THIS AGREEMENT made this 22<sup>nd</sup> day of February , 2024 between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines ( hereinafter called the “ Entity” ) of the one part and **MS. FATIMA E. LEE** Proprietor of **F.E. LEE Sportsbar and Restaurant** ( hereinafter called the “Supplier” ) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **PROVISION FOR FOOD AND DRINKS FOR THE WOMEN’S MONTH CELEBRATION** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Six Hundred Fifty Two Thousand Three Hundred Twenty Five Pesos ( ₱ 4,652,325.00 ) Only** (hereinafter called “the Contract Price”).

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of of **Four Million Six Hundred Fifty Two Thousand Three Hundred Twenty Five Pesos ( ₱ 4,652,325.00 ) Only** or such other sums as may be ascertained, **F.E. LEE Sportsbar and Restaurant** agrees to **PROVISION FOR FOOD AND DRINKS FOR THE WOMEN’S MONTH CELEBRATION** in accordance with his/her/its Bid.
