THIS AGREEMENT made this 7th day of March , 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. FATIMA E. LEE Proprietor of F.E. LEE Sportsbar and Restaurant (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz CATERING SERVICES FOR THE CONCENTRATION TRAINING OF ATHLETES, SPORTS AND TRAINING OFFICIALS OF 2024 PALARONG BICOL and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Three Million Two Hundred Twenty Two Thousand One Hundred Eighty Pesos (**P** 3,222,180.00) Only (hereinafter called "the Contract Price").

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
