

CONTRACT AGREEMENT

THIS AGREEMENT made this 11th day of December, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and RYAN BELLEZA Branch Manager of **DENVER COMPUTER SHOPPE, INC.** (hereinafter called the "Supplier") of the other part:

Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
