

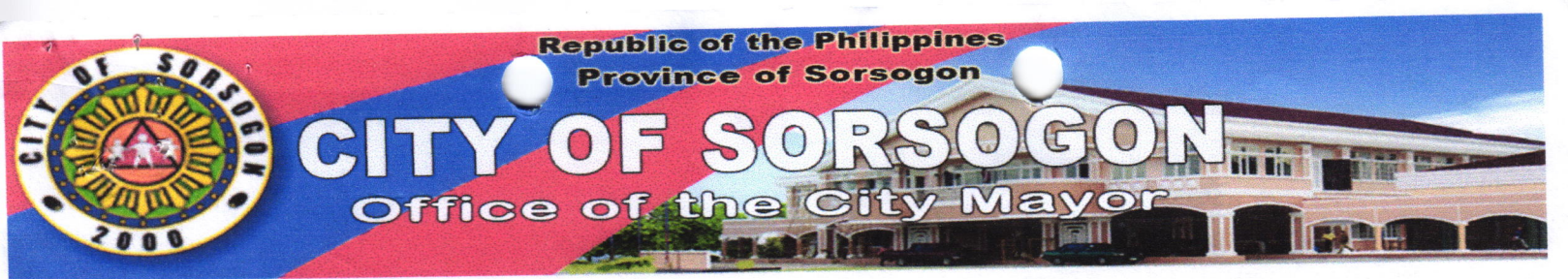

CONTRACT AGREEMENT




