### Contract Agreement No. B- 2023-2264-GS

THIS AGREEMENT made this 20<sup>th</sup> day of November 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and MS. EDEN D. DIG Proprietor of SUPER E ENTERPRISES (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz SUPPLY AND DELIVERY OF MEDICAL SUPPLIES FOR THE CITY HEALTH OFFICE AND 3 RHU's and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Nine Hundred Fifty Two Thousand Seven Hundred Five and 10/100 Pesos (Php 1,952,705.10) Only (hereinafter called "the Contract Price").

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **One Million Nine Hundred Fifty Two Thousand** Seven Hundred Five and 10/100 Pesos (Php 1,952,705.10) Only or such other sums as may be ascertained, SUPER E ENTERPRISES agrees to SUPPLY AND DELIVERY OF MEDICAL SUPPLIES FOR THE CITY HEALTH OFFICE AND 3 RHU's in accordance with his/her/its Bid.
