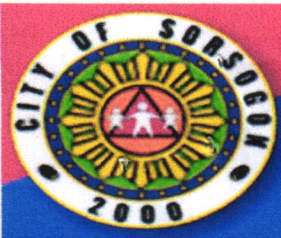



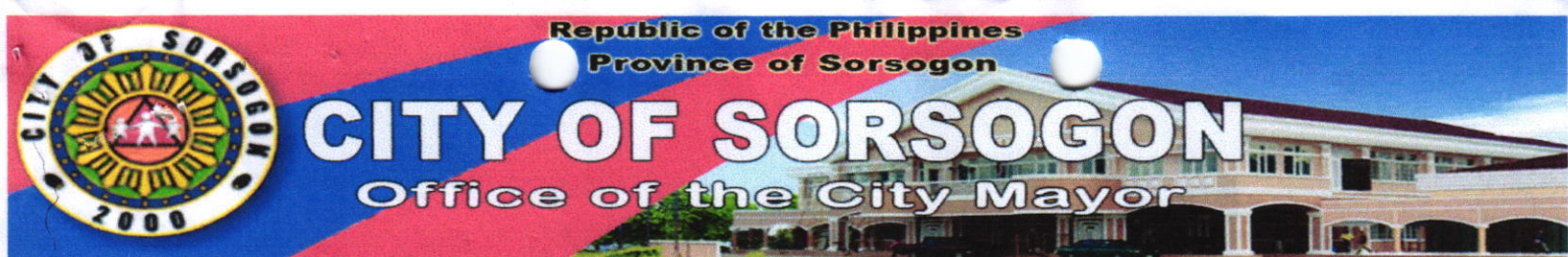

CONTRACT AGREEMENT
