- The City Government of Sorsogon now invites bids for the above Procurement Project. Delivery of the Goods is required by within **(90) Ninety Calendar Days** . Bidders should have completed, within (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II of the Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from *the City Government Bids and Award Committee* and inspect the Bidding Documents at the address given below from **9:00 AM to 3:00PM only**.
- A complete set of Bidding Documents may be acquired by interested Bidders on **May 24, 2024** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand (Php 5,000.00) Pesos per LOT*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *after payment has been made* .

9. Bid opening shall be on **June 17, 2024 @ 9:00 A.M for LOT 1 and June 17, 2024 @ 10:00 A.M for LOT 2** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity .
