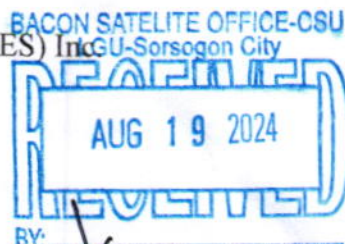
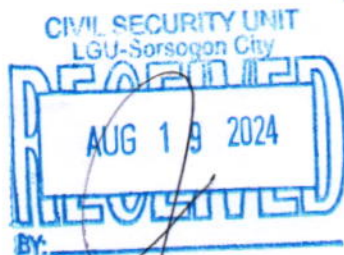

## CONTRACT AGREEMENT

This Agreement is made and entered in to by and between:

The **CITY GOVERNMENT OF SORSOGON**, a Local Government Unit created pursuant to Republic Act 8806, with office address at Sorsogon City Hall Building, Barangay Cabid-an, East District, Sorsogon City, duly represented by **Hon. MA. ESTER E. HAMOR**, City Mayor, hereinafter referred to as the First Party;

The **INDEPENDENT BASKETBALL REFEREES EDUCATION OF SORSOGON (IBRES) INC.**, an organization for officiating in sporting activities with an office in Barangay Burabod, East District, Sorsogon City, duly represented by **Mr. REYNALDO D. REGALA**, representative, hereinafter referred to as the Second Party;

### WITNESSETH:

**WHEREAS**, the City Government of Sorsogon is committed to serve its employees through the adoption of major activities and development programs to create physical & mental fitness awareness. These undertakings require the rental of sports facilities;

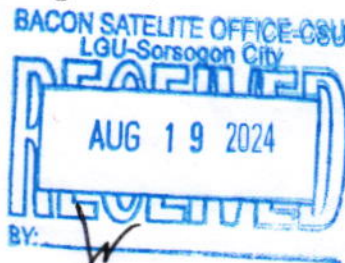
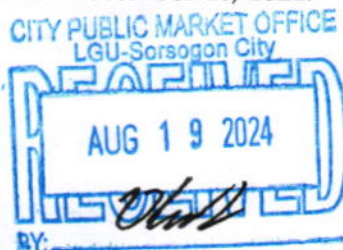
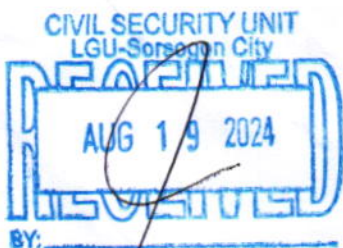
**WHEREAS**, under the Government Procurement Reform Act (RA 9184), the Head of the Procurement entity, through the recommendation of its Bids and Awards Committee (BAC) may adopt the alternative mode of Negotiated Procurement of Individual law, which states: "Negotiated Procurement is a method of procurement goods, infrastructure projects and consulting services, whereby the procuring entity directly negotiated a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following cases: (Sec 53.0 IRR-A) a) xxxxx xxxxx xxxxx f) in the case of individual consultants hired to do that is (1) highly technical or propriety; or (ii) primarily confidential or policy determining, where trust and confidence are the primary consideration for the hiring of the consultants: Provided, however, that the term of the individual consultants shall, at the most, be on a six (6) month basis, renewable at the option of the appointing head of the procuring entity, but in no case shall exceed the term of the latter:"

**WHEREAS**, the **SECOND PARTY** undertakes to provide officiating services (Running and Table Officials) for the Sulay Sa Futuro Sports League with the **FIRST PARTY**, particularly on the following task:

1. Provision of officiating services (Table Officials) for 5 on 5 basketball tournament during the conduct of Sulay Sa Futuro Basketball Developmental League for Elementary and Secondary pupils and students.

**WHEREAS**, the parties have hereunto entered into a contract of service, under the following terms and conditions:

- a. **Service Fee** - The First Party shall pay the Second Party a service fee amounting to **One Hundred Fourteen Thousand Three Hundred & 0/100 (P 114,300.00)** only, Philippine currency for 5 on 5 basketball (elementary and secondary level).
- b. **Duration** - The 5 on 5 tournament shall commence on August 17, 2024 and will tentatively end on December 16, 2024.




