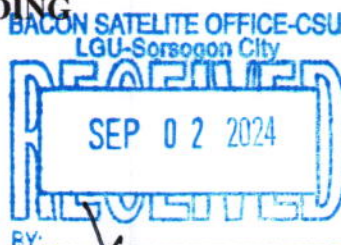
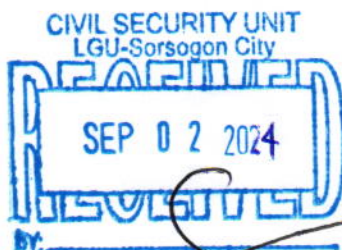

CONTRACT AGREEMENT

THIS AGREEMENT made this 29th day of August , 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity”) of the one part and JADE T.
