THIS AGREEMENT made this **29th** day of **August ,2024** between **Ma. Ester E. Hamor** , City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity”) of the one part and **ARLENE D. 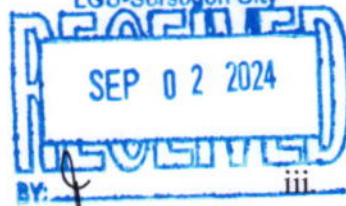

- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

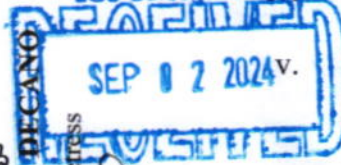

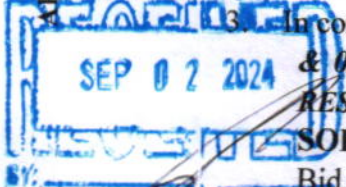

4. The City Government of Sorsogon agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




