## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 20th day of November , 2024 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the " Entity" ) of the one part and ALWAYNE DEAN MATEOS DELIGERO Authorized Representative of BLACKPAJAMA COMPANY( hereinafter called the "Supplier" ) of the other part:

> Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In physideration for the sum of sum Two Hundred Forty Seven Thousand Five Hundred Pesos (Php 247,500.00) Only or such other sums as may be ascertained. **BLACKPAJAMA COMPANY** agrees to viz SUPPLIES AND DELIVERY OF TROPHIES AND MEDALS FOR THE AWARDING OF SULAY SA **FUTURO SPORTS LEAGUE SEASON 2** in accordance with his/her/its Bid.

The City Government of Sorsogon agrees to pay the above-mentioned sum in 4. accordance with the terms of the Bidding.
