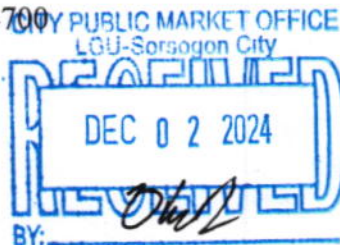
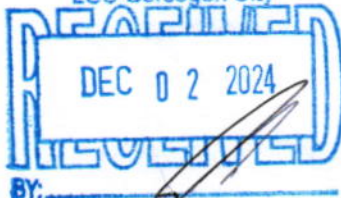

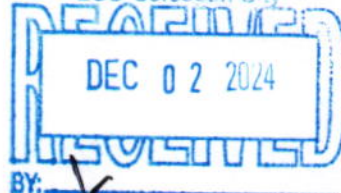

CONTRACT AGREEMENT
