CONTRACT AGREEMENT

THIS AGREEMENT, made this 10th day of March, 2025 between CITY GOVERNMENT OF SORSOGON, City Hall, Cabid-an East Dist. Sorsogon City (hereinafter called the "Entity") and RMH CONSTRUCTION & SUPPLY with office address 17TH OLV PANGPANG, SORSOGON CITY (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute CONSTRUCTION/INSTALLATION OF SOLAR STREETLIGHTS @ PIER SITE BRGY. TALISAY WEST DISTRICT Sorsogon City under Contract Reference No. CW 2025-01-003 (hereinafter called "the Works") and the Entity has accepted the Bid Nine Million Nine Hundred Eighty Two Thousand Nine Hundred Three & 80/100 Pesos (Php 9,982,903.80) Only by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- f. Winning bidder shall present Tax Clearance (for Collection) from the Bureau of Internal Revenue as well as a copy of Business and Income Tax returns duly stamped and received by Bureau of Internal Revenue duly validated with the tax payment made thereon.

3. In consideration for the sum of Nine Million Nine Hundred Eighty Two Thousand Nine Hundred Three & 80/100 Pesos (Php 9,982,903.80) Only or such other sums as may be ascertained, RMH CONSTRUCTION & SUPPLY agrees to CONSTRUCTION/INSTALLATION OF SOLAR STREETLIGHTS @ PIER SITE BRGY. TALISAY WEST DISTRICT Sorsogon City in accordance with his/her/its Bid.






