





CONTRACT AGREEMENT

THIS AGREEMENT made this 26th day of November, 2024 between Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines (hereinafter called the “ Entity”) of the one part and AZEL B. ROSAS Proprietress of AZLJ CONSTRUCTION (hereinafter called the “Supplier”) of the other part:

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder’s conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Four Hundred Eighty-Two Thousand Nine Hundred Sixty Pesos & 50/100 (P 482,960.00) Only** or such other sums as may be ascertained, **AZLJ CONSTRUCTION** agrees to viz **SUPPLY AND DELIVERY OF MATERIALS FOR THE FABRICATION OF 14 UNITS MRF @ VARIOUS BARANGAY**, in accordance with his/her/its Bid.




