

CONTRACT AGREEMENT

THIS AGREEMENT made this 3rd day of Febraury , 2025 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and **BRYAN D. OLAYRES** Authorized Representative of BRYSAM SORSOGON PRINTING SERVICES

(hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz PRINTING OF SANITARY PERMIT, HEALTH CARDS AND OTHER HEALTH FORMS FOR USE IN BUSINESS ONE STOP SHOP (BOSS 2025) during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum <u>Two Hundred Ninety Two</u> Thousand Pesos (# 292,000.00)) Only (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - Supplemental or Bid Bulletins, if any iv.

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that SECURITY UNIT additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of <u>Pesos (₱ 292,000.00)) Only</u> or such other sums as may be ascertained, BRYSAM SORSOGON PRINTING SERVICES agrees to viz <u>PRINTING OF</u> <u>SANITARY PERMIT, HEALTH CARDS AND OTHER HEALTH FORMS FOR USE</u> <u>IN BUSINESS ONE STOP SHOP (BOSS 2025)</u> in accordance with his/her/its Bid.

4. The <u>*City Government of Sorsogon*</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
