CONTRACT AGREEMENT

THIS AGREEMENT made this 21st day of February, 2025 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ROY A. MANGUBAT Authorized Representative of NEEDINK SALES & SERVICES (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of 3. sum One Hundred One Thousand Pesos (P or such other sums as may be ascertained, NEEDINK SALES & 101,000.00)) Only SERVICES agrees to viz SUPPLY AND DELIVERY OF TONER CARTRIDGE FOR in accordance with his/her/its Bid. PHOTOCOPIER FOR USE AT BAC OFFICE_

The City Government of Sorsogon agrees to pay the above-mentioned sum in 4. accordance with the terms of the Bidding.
