CONTRACT AGREEMENT

THIS AGREEMENT made this 18th day of February ,2025 between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon Philippines** (hereinafter called the “ Entity”) of the one part and **HANS GRETZEL J. LORBES** Authorized Representative of **PEACHES KITCHENETTE.**(hereinafter called the “Supplier”) of the other part:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

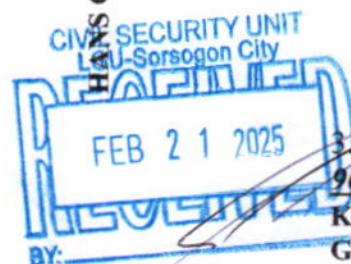
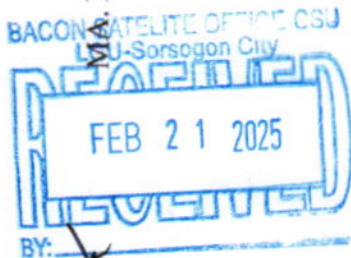
- iii. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of sum **Ninety Six Thousand Pesos (₱ 96,000.00)) Only** or such other sums as may be ascertained, **PEACHES KITCHENETTE.** agrees to viz **CATERING SERVICES FOR THE SINING GALING NATIONAL ARTS MONTH DIVISION OF FESTIVAL OF TALENTS** in accordance with his/her/its Bid.
