### **CONTRACT AGREEMENT**

THIS AGREEMENT made this 6th day of March, 2025 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines ( hereinafter called the "Entity" ) of the one part and FATIMA Authorized Representative of F. E. LEE ENTERPRISES( hereinafter called the E. LEE "Supplier" ) of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the v. Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB VIL SECURITY UNIT that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of sum Sixty Eight Thousand Seven Hundred Sixty Six and 50/100 Pesos ( P 68,766.50) Only or such other sums as may be ascertained, F. E. LEE ENTERPRISES agrees to viz the SUPPLY AND DELIVERY **OF MEDALS FOR THE 2025 PALARONG BICOL** in accordance with his/her/its Bid.

4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
