CONTRACT AGREEMENT

THIS AGREEMENT made this 6th day of **March , 2025** between **Ma. Ester E. Hamor , City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **JOSE BONIFACIO L. LASALA** Authorized Representative of **J.L. ENTERPRISES**(hereinafter called the “Supplier”) of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **CATERING SERVICES FOR THE AWARENESS ON THE ANTI VIOLENCE AGAINST WOMEN AND THEIR CHILDREN SYMPOSIUM** during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Eighty Four Thousand Pesos (P 84,000.00) Only** (hereinafter called “the Contract Price”).

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;

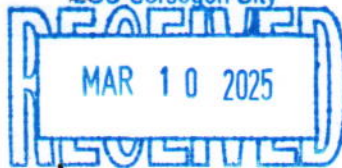
Notice of Award of Contract; and the Bidder’s conforme thereto; and

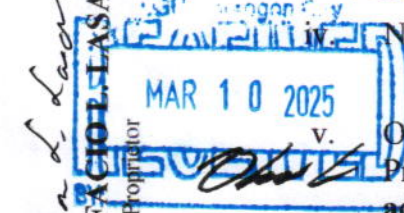

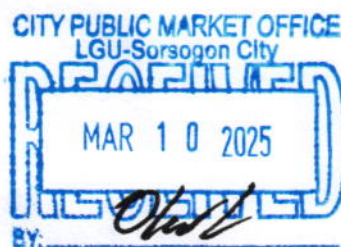
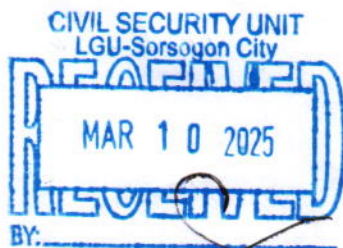
